VOTER REGISTRATION

You must be a registered voter in the City of Lake Butler for the past six months to run for city commissioner.

VOTER REGISTRATION DEADLINE

May 28, 2024, at 5:00

QUALIFYING DATES

April 15, 2024 - April 19, 2024 Noon Monday till Noon Friday

QUALIFYING FEE

1% of Salary: Plus 20 Signatures or \$25

Commissioner – Salary - \$10,674.56 / 1%= \$106.75

Total for Commissioner -= \$131.75

Qualifying fees must be paid out of the Campaign Account.

Signature verification is \$.10 per name paid to UCSOE from your Campaign Account.

The Appointment of Campaign Treasurer and Designation of Depository MUST be on file before you:

- Collect or spend money for your campaign.
- Open a campaign bank account.
- Collect petition signatures.

FORMS TO BE FILED

Form DS-DE 9 – Appt. of Campaign Treasurer & Depository

This form is required to be filed with the Supervisor of Elections prior to opening your campaign account, accepting contributions, making expenditures, or collecting signatures.

Form DS-DE 84 – Statement of Candidate.

Must be filed within 10 days of opening campaign account.

DS-DE 25 - Loyalty Oath.

Due during qualifying period.

Form 6 - Full and Public Disclosure of Financial Interests.

Must be on file prior to qualifying. Effective January 1, 2024, All Form 6's must be filed online.

Reports start once the campaign account is opened.
