# AN ORDINANCE APPROVING THE ANNUAL OPERATING BUDGET AND RELATED SCHEDULES FOR THE FISCAL YEAR OF 2025-2026 AND ACKNOWLEDGEMENT PROVIDING FOR RECEIPT OF GRANT FUNDS AND DISBURSEMENT OF SAME

WHEREAS, the City Commission of the City of Lake Butler held a budget work session on May 8, 2025 with a continuation work session on July 10, 2025; with a continuation work session on August 21, 2025 and an initial public hearing on September 4, 2025 plus a second public hearing scheduled on September 16, 2025; and

WHEREAS, the annual operating budget covers a period of October 1, 2025, through September 30, 2026, and is considered the fiscal year; and

WHEREAS, the City Commission has reviewed the recommendations of the Mayor, in her authority and responsibilities given by the City Commission, and concurs so that said services of the City will continue to operate in a safe and sound manner; and

WHEREAS, the annual operating budget for the City of Lake Butler has been reviewed and the necessary publications and public hearings have been complied with; and

WHERAS, the annual operating budget is approved on a departmental level; and

WHEREAS, the City Manager may adjust the detailed line items within the department, if it does not change the departmental totals, which are approved by the City Commission; and

WHEREAS, the supplemental schedules for utility rates and fees are adopted; and
