Cancelled the Windstream Backup Internet Connection. It was found that this was not a true backup, and when city hall lost internet connection, the Windstream service also went offline. Cost savings \$120.00/month.

2021 Suburban sale was finalized with CarMax. The money for it was placed in a commission recommended restricted account as requested. \$46,400. As per request, I was given a contact with an individual at the City of Gainesville that handles their surplus vehicles, and we will be meeting them within the next week for me to view vans they have available. I will present to the Commission the information and price on any I find suitable for our needs.
