The question of quorum will need to be investigated with the possibility of changing regulations due to the pandemic situation affecting local government meetings.

E. REPORT OF CITY MANAGER

- -The rotary club has been honoring veterans with the roadside crosses and flags on Highway 121 through town.
- -Lake Butler will be hosting the drag boat races in April with the Southern Drag Boat Association.
- -There has been a lot of work done to remove weeds from the lake in the last month and the area is looking much improved.
