- Motion to approve the Consent Agenda in one motion was made by Commissioner Hendrix and seconded by Commissioner Stegall.

Action: 2. Financial Reporting for Period Ending June 30, 2022

- Report presented by Mr. Walker.
 - o The internal loans for the purchase of the new public works property are complete.
 - Public works is over budget due to the repair of the splashpark.
 - The Wastewater fund has gotten a lot of grants including one for the purchase of a bucket truck.
 - The city has secured donations of around \$10,000 for the Downtown Redevelopment account.
- Motion to approve the financial report for the period of October 1, 2022, through June 30, 2022, was made by Vice Mayor Redman and seconded by Commissioner Stegall.
- Unanimous Approval

Information: 3. Mayor's Art Award

- Mayor Schenck presented the award to the winners of the Mayor's art contest held on July 2, 2022.
- Third place Julia Brannen, received a certificate and an award check for \$100.
- Second place Daveyon Moss, received a certificate and an award check for \$300.
- First Place Camrin Hillard, received a certificate, and an award check for \$500. The first place art piece will hang in the Commission Chambers for the public to view.

Action: 4. Utility Rates

Recommended Action: Motion to approve Resolution Number 2022-02 for utility rates for the 2022-2023 fiscal year.

 Proposed utility rates and a preliminary budget for the water, wastewater, and solid waste funds were presented by Mr. Walker.

Water Fund

- o The water holding tank is damaged. The state legislature has awarded an \$800,000 grant to replace it.
- The average monthly water use in Lake Butler is 5,400 gallons per month. A 10% increase in use charges is recommended.
- The net position shows the retained earnings for the past few years.
- The Water fund has a small amount of debt.

- Regarding expenditures, operating expenses are up due to having the repair and replacement of water lines.
- The net income is expected to be in the red for a few years.

Wastewater

- The city processes 750,000 gallons per day with service furnished to the city and the prison.
- A 10% increase is recommended for use charges.
- The Wastewater fund has received \$30 million in grants.
- The solar array for the new wastewater treatment plant will save thousands each year. The wastewater treatment plant will be self-contained and the sprayfield will no longer be needed once the facility is complete.
- Replacement of current and the building of new lift stations will be covered by a \$3 million grant from the Governor.
- There are increases in debt coverage and net coverage.
- Fund Goals: -
 - Legislative appropriation approval for the collection system;
 - Build the new wastewater treatment plant;
 - Build the wetlands.
- The city has received \$7 million in revenue, mostly from grants.
- o The fund has \$1.5 million in contingency funds for the wastewater treatment plant build.
- There are currently 11 projects in the works. \$40 million of these project costs are paid 99% with grants and 1% as low-interest loans to the city.

Solid Waste

- A proposed increase of 5% is recommended for residential rates.
- An increase to commercial rates of 25% is recommended as these rates have remained unchanged for several years.
- The fund balance is intended to take care of radius repair for damage to street curbs caused by the large garbage trucks.
- There is a slight net income.
- Motion to approve Resolution Number 2022-02 for utility rates for the 2022-2023 fiscal year was made by Commissioner Stegall.
- The resolution was read by Mr. Maines.
- Motion seconded by Vice Mayor Redman.
- Unanimous Approval

Action: 5. New Public Works Building

- Mr. Walker explained that the new public works property needs to complete the build-out of the shed so the move to the new property can begin. This will also allow Welch's to move from Main Street to the current public works building.
- Motion to approve up to \$30,000 from the General fund for construction of the new Public Works garage was made by Vice Mayor Redman and seconded by Commissioner Stegall.
- Unanimous Approval

Action: 6. Contract with CHW

- Mr. Walker stated that the current sprayfield will not be needed once the new wastewater treatment plant construction is complete. CHW will evaluate the land and make a recommendation for the best land use.
- Motion to approve the contract with CHW was made by Commissioner Hendrix and seconded by Vice Mayor Redman.
- Unanimous Approval

Action: 7. Bucket Truck Purchase

- Motion to approve the purchase of the bucket truck from Custom Truck for \$144,484 was made by Commissioner Stegall and seconded by Vice Mayor Redman.
- Unanimous Approval

Discussion: 8. Public Hearing for Bucket Truck

- Pubic Comments or Questions:
 - o Rondoll Huggins, 640 SE 4th St, Lake Butler, Florida 32054
 - Mr. Huggins asked the commission how much of the cost of the bucket truck will be covered by the grant and how much will have to be paid by the city.
 - Mr. Walker clarified that the grant will provide \$108,000 and the city will pay \$35,000.
- Motion to close the public hearing was made by Vice Mayor Redman and seconded by Commissioner Hendrix.
- Unanimous Approval

Action: 9. Bucket Truck Loan Resolution

- Motion to approve the USD Loan Resolution as indicated in item nine for the purchase of a bucket truck was made by Vice Mayor Redman and seconded by Commissioner Stegall.
- Unanimous Approval

Action: 10. Lease

• Mayor Schenck indicated that this lease is intended to replace the individual event leases for the Driggers lakeside property with an annual lease in exchange for \$10 per year and regular maintenance of the grounds by Public Works. This

lease covers three yearly events; two yearly boat race events and the Independence Day celebration. Additional events will require the city to request permission from Mr. Driggers to have them covered by the lease individually.

- Motion to approve the lease agreement with Robert A Driggers Jr. was made by Commissioner Sirmones and seconded by Vice Mayor Redman.
- Unanimous Approval

- The commission agreed that each member would contribute \$50 to the Tiger Purple membership from the upcoming paycheck.
