One of the contingencies of the commercial contract is that the applicant will apply for a rezoning of the subject parcel from the current zoning district of Commercial General (CG) & the current future land use classification of Commercial to Industrial (I) on the Zoning Atlas & Industrial (I) on the Future Land Use Map, which requires an application be filed by the buyer to amend the Official Zoning Atlas (LDR Amendment) & the Future Land Use Map (Comprehensive Plan Amendment).
